Huai Pin commenced her training as a practice trainee in TKQP before joining as an Associate with the insurance litigation department.

During her time in TKQP, she regularly represents and advises insurers on most classes of insurance, ranging from professional indemnity, contractor's all-risks, public liability, work injury compensation, motor insurance and performance bonds.

Huai Pin also has had the opportunity of being involved in some of the high-profile personal injury litigation cases:

- being part of the team in defending claims arising out of an accident along Ayer Rajah Expressway, where the driver had driven against the flow of traffic, leaving 1 dead and 4 injured;
- being part of the team in advising on and defending a claim for inheritance following the death of a director and shareholder of an oil and gas company;
- advising on a claim made on a professional indemnity policy in view of allegations made against a real estate agent;
- being part of the team in advising a claim made on a public liability policy and defending a well-known US food and beverage chain in a claim for damages brought about by a contractor's employee pursuant to a fall from height, leaving the said employee wheelchair-bound; and
- being part of the team in successfully appealing against the High Court decision to award pre-trial loss of earning capacity: *Yap Boon Fong Yvonne v Wong Kok Mun Alvin and Anor* [2019] 1 SLR 230.

In her course of work, Huai Pin regularly deals with and handles complex policy review and disputes. She also occasionally advises on review of insurance contracts and re-drafting of insurance policies.

Huai Pin then left TKQP in 2019 to join Rajah & Tann. There, she shifted her focus to mainly contractual and commercial disputes litigation, with a focus on employment disputes. During her time there, she has had the opportunity of advising some of the largest multinational corporations/small medium enterprises in claims relating to wrongful dismissal, unfair/discriminatory employment practices and workplace sexual harassment claims.

Huai Pin also continued to be involved in some of the personal injury litigation cases which include:

- being part of the team in representing a former RSAF pilot in her claim for damages arising out of a road traffic accident, in which her claim for damages was quantified at \$4 million;

- being part of the team in advising on and defending a government-owned corporation in a personal injury claim brought by a former employee, in which his claim was quantified in the excess of \$1million.

Huai Pin then re-joined TKQP in mid- 2020 as a Senior Associate with the insurance litigation team. Since her return, she has continued to act for insurers in various classes of insurance.
